### **Measuring:**

There will be at least **1 VMO** at the trial. **ALL** dogs without a valid Jump Height Card/Form must be measured **before** its first run of the trial. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores. You don't have to be there hours before your run, but do not wait until the last minute before you are to run to have your dog measured.

### **Parking:**

**RV's may not be parked overnight or in the lot in the front of the building or in any of the surrounding businesses' parking lots, unless special arrangements have been made.** They may be parked on the side of the building during trial hours.

### **Crating:**

**Club members and handicapped only may set up on the turf area by the ring. Waterproof tarps are required under crates. High occupancy x-pens only. Tables only if crates are underneath. Folding carts must be kept folded if kept inside. Please help conserve space!**

**FOOD!!! There is no food on site, there are several fast-food restaurants close by**

### **Move-ups**

Move-ups are due by 6 pm March 4, 2024 in writing (email is preferred). Day to day move-ups is allowed and must be given to the Trial Secretary immediately after the last class. Getting them to the Trial Secretary as soon as possible is very much appreciated.

### **Volunteers**

You make it possible for trials to happen and be successful. THANK YOU!!! You can sign up at the trial, Volunteers will be given vouchers for a future BRDTC agility entry. There will also be a worker raffle at the trial each day.

## Directions

From the North or South: Interstate 81, Exit 310 (Kernstown). Take Route 37 and immediately take Route 11 North about 2/10 of a mile to Commonwealth Court and then right to the end of the road. Gander Mountain is to the right; Body Renew is to the left.

Dogs must be exercised on lead in the designated areas only. Failure to comply and failure to clean up after your dog at the trial site or motel will result in the exhibitor being excused from the trial without a refund. No Flexi-leads are to be used in the building or near the doors.

E/M STD and EX/M JWW 4-16 Walk, Walk Run, 20-24 Walk Run
